Additional Charges

Description	Rate
Administration/Handling Fee for consumer-selected third-party goods or services	10%

An administration handling fee applies for third-party goods or services you choose, and this will be included in the all-inclusive amount charged per transaction. This fee does not apply to the services listed in this rate card. The fee is 10% of the cost, capped at \$500 per transaction. Examples include items such as continence pads, meal services (e.g. Light N' Easy), or mobility aids.

Care Management Fee

The Australian Government now sets care management fees at 10% of your subsidy value. For example, as of 1 November 2025, if you're on a Level 2 package, your government-funded subsidy will be \$4,845.60 per quarter, in which your quarterly care management fee will be \$484.56.
